

II. After The Flood

1. Origin Of The Post-Flood Giants

Gen 6:4

There were giants in the earth in those days; and **also after that**, when the sons of God came in unto the daughters of men, and they bare *children* to them, the same *became* mighty men which *were* of old, men of renown.


- The phrase ALSO AFTER THAT refers to the giants that were in the earth after the days of Noah
- The fact there were giants after the Flood is undeniable, and they were clearly beings of great STATURE

Num 13:32-33

And they brought up an evil report of the land which they had searched unto the children of Israel, saying, The land, through which we have gone to search it, *is* a land that eateth up the inhabitants thereof; and all the people that **we saw** in it *are* **men of a great stature**.

And there **we saw the giants**, the sons of Anak, *which come* of the giants: and we were in our own sight as grasshoppers, and so we were in their sight.

Deu 2:10-11


The Emims dwelt therein in times past, a people great, and many, and **tall**, as the Anakims; Which also were accounted **giants**, as the Anakims; but the Moabites call them Emims.

- If all the giants were destroyed by the Flood, how could they re-appear on the earth AFTER the Flood?


1) The SURVIVAL Theory

- This theory states that some of the giants actually survived the Flood by escaping to outer space or inner earth before the Flood wiped out the earth
- One Hebrew tradition holds that Og (Deu 3:11) lived before the Flood and actually survived by holding on to a rope outside the ark; Noah agreed to feed him through a port hole in the ark
- This theory is impossible because the Bible clearly states that everything that WAS upon the face of ground was destroyed and there were no survivors outside the ark

Gen 7:23

And every living substance was destroyed which was upon the face of the ground, both man, and cattle, and the creeping things, and the fowl of the heaven; and they were destroyed from the earth: and Noah only remained alive, and they that were with him in the ark.



- This theory is impossible because it violates scriptural typology
 - The ark is a type of Jesus Christ and the Flood is the judgment of God
 - The only way to escape the judgment of God is to be IN CHRIST (Heb 2:3)
 - If anyone or anything outside the ark of safety survived the Flood, it would picture salvation outside of Christ which is impossible

2) The RESURRECTION Theory

- This theory states that although the giants were destroyed in the Flood, some were resurrected after the Flood
- This theory is impossible because only MEN will be resurrected, not animals, angels, or hybrids- giants are NOT men but hybrids
- In addition, there is an ORDER to the resurrection and IF any giants will be resurrected, they would be part of the SECOND resurrection (i.e.- the resurrection of damnation) at the end of the Millennium

1 Cor 15:22-24a

For as in Adam all die, even so in Christ shall all be made alive.

But **every man in his own order**: Christ the firstfruits; afterward they that are Christ's at his coming.


Then *cometh* the end

John 5:29

And shall come forth; they that have done good, unto the resurrection of life; and **they that have done evil, unto the resurrection of damnation.**

Rev 20:5a

But the rest of the dead lived not again until the thousand years were finished.

3) The MULTIPLE INCURSION Theory


- This theory states that there was another invasion of fallen angels and cohabitation with women after the Flood
- This theory is possible from the wording in Genesis 6:4, which implies that the sons of God came in unto the daughters of men both “in those days” and “also after that”

Gen 6:4

There were giants in the earth in those days; and **also after that, when the sons of God came in unto the daughters of men,** and they bare *children* to them, the same *became* mighty men which *were* of old, men of renown.

- It is interesting to note that there is no clear scriptural evidence beyond this that another incursion took place
- 2 Peter 2:4 and Jude 6 provide additional evidence of the incursion that took place BEFORE the Flood, including the judgment pronounced upon the offending angels



- If another incursion took place **AFTER** the Flood it seems scripture would indicate what happened to the offending angels
- Some argue that the four angels bound in the Euphrates river (Rev 9:14) are the offending angels, but there are problems with this argument
 - Why would fallen angels guilty of committing fornication with women after the Flood be bound in the **EUPHRATES** river when fallen angels guilty of the same sin before the Flood were cast down to **HELL** (2 Pet 2:4)?
 - Why would fallen angels guilty of committing fornication with women after the Flood be **LOOSED** from their judgment to slay men (Rev 9:14-15) when fallen angels guilty of the same sin before the Flood are **RESERVED** in everlasting chains until their day of their final judgment (Jude 6)?
- A problem with this theory is that the Anakims are said to **COME OF** the pre-Flood giants (the word **GIANTS** is the Hebrew word *nephiyl* both times) which could not be the case if they are the offspring of another cohabitation of fallen angels and women

Num 13:33

And there we saw **the giants, the sons of Anak**, which **come of the giants**: and we were in our own sight as grasshoppers, and so we were in their sight.



4) The GENETIC PRESERVATION Theory

- This theory states that even though the giants themselves were destroyed in the Flood, their DNA was preserved in the ark
- If this theory is true, then the likely candidate is Ham's wife
 - It could not be preserved through Noah, his wife, or any of his sons because the Bible states that Noah was “**perfect in his generations**” (Gen 6:9)- in other words, his genes and those of his offspring were without blemish
 - All the post-Flood giants are associated with family of HAM, specifically through his son CANAAN (Gen 9:25; 10:15-16; Num 13:29,32)
- This theory is improbable on the basis of at least two points
 - The purpose in destroying all flesh in the Flood was to eradicate the earth of the genetic corruption that occurred- why would the Lord allow it to be preserved in the ark?
 - If someone on the ark was not genetically perfect, that would violate the typology of the ark because all those who are saved are “**perfect in Christ Jesus**” (Col 1:28)



5) The GENETIC DUPLICATION Theory

- This theory states that giant DNA was discovered or given to man after the Flood and somehow used to “clone” a new race of giants
- This theory is plausible but improbable- it produces a number of questions that cannot be answered at this time
 - Where is the scriptural evidence that cloning procedures occurred after the Flood?
 - Where did the knowledge and technology of cloning originate and why wasn't it passed down through human history?
 - If “blank” (i.e.- spiritless) giant bodies were re-produced, where did the spirits come from to give life to the bodies?
 - If the genetic material to be cloned was that of a previous and judged race of giants, how could another spirit take up permanent and sole residence of the body?

Note: Concerning the last point, given what happened BEFORE the Flood, it is clear that Satan possesses the knowledge to step over or go around the reproductive and generative bounds the Lord has set



6) The GENETIC INFUSION Theory

- INFUSION= “to cause to be permeated with something **that alters**, usually for the better; to introduce one thing into another **so as to affect throughout**; implies a pouring in of something that **gives new life** or significance” (emphasis mine)
- This theory states that giant DNA was discovered or given to man after the Flood and mingled with the DNA of a willing recipient, transforming them into a giant
- This theory may seem like science fiction, but not when you realize that people today are injecting themselves with steroids and human growth hormones (HGH) to enhance their body mass and physical abilities
- There is no doubt that Satanic beings possess advanced genetic knowledge, and could inform the right man on where to find giant DNA (location), how to harvest it (extraction), and how to integrate it (infusion) with his own in order to become a “god”

- If this theory is true, then the likely candidate is Nimrod
 - NIMROD only appears 4x (# of the SPIRIT REALM) (Gen 10:8-9; 1 Chr 1:10; Mic 5:6) but what can be gleaned bears witness to the evil tradition surrounding him
 - NIMROD= from the root word *marad* meaning, “rebel”- Nimrod is the 13th (# of REBELLION) from Adam
 - Could also be from the word *namer* meaning, “leopard” cf. (Rev 13:2)


Gen 6:4; 10:8-9

There were **giants** in the earth in those days; and also after that, when the sons of God came in unto the daughters of men, and they bare *children* to them, **the same became mighty men** which *were* of old, men of renown.

And Cush begat **Nimrod**: **he began to be a mighty one** in the earth.

He was a **mighty** hunter before the LORD: wherefore it is said, Even as Nimrod the **mighty** hunter before the LORD.



- At the very least, Nimrod demonstrated powers and abilities that were comparable to those of the giants before the Flood in that they were extraordinary and super human
- It is also possible that he began to be a MIGHTY ONE because he began to be a GIANT, since that is what the MIGHTY MEN of old were
- The word MIGHTY appears 4x (# of the SPIRIT REALM) in Genesis 6:4 and Genesis 10:8-9
- MIGHTY= Heb. *gibbowr* which is translated MIGHTY MAN 68x; MIGHTY 63x; STRONG 4x; VALIANT 3x
- It is also translated CHAMPION 1x in reference to Goliath (1 Sam 17:51) and GIANT 1x (Job 16:14)
- The word is used to refer to the giants (Gen 6:4), Nimrod (Gen 10:8-9), the Lord (Deu 10:17; Isa 9:6), men of valor (Jos 1:14; 2 Sam 23:22), the glorified saints (Isa 13:3; Joel 3:11), Alexander the Great (Dan 11:3), and a supernatural army (Joel 2:7)
- As such the word describes extraordinary, superhuman, godlike strength, power, and abilities



- BEGAN= Heb. *chalal* which is translated BEGIN/BEGAN 52x (4 x 13); PROFANE 36x (6 x 6); POLLUTE 23x; and DEFILE 9x; it means “to begin; to profane, pollute, or defile oneself ritually or sexually”
- The way the word is used in Genesis 10:8 may indicate HOW Nimrod BEGAN to be a MIGHTY one
- If all this is true, then Nimrod began to be a giant when he profaned and defiled himself
- BEFORE= Heb. *paniyim*= used in the sense of “against”

Exo 20:3

Thou shalt have no other gods **before** me.

- Nimrod was a rebel against God and the first antichrist in the Bible- he was the ringleader in building the tower of Babel, the first attempt at a world government and religion (without God)
- Nimrod did not just hunt animals, but also men’s souls cf. (Eze 13:18)
- He founded the first KINGDOM in the Bible founded FOUR (# of the SPIRIT REALM) cities (Babel, Erech, Accad, and Calneh) in the land of Shinar (Gen 10:10) and IDOLATRY
